PCN NOTIFICATION

In some Member States it is necessary to wait for confirmation from the competent body before placing products on the market. This information is provided by the PCN portal, or you can consult the list of Poison Centers by clicking [here](#)

Regarding Italy, the Decree of 28 December 2020 was introduced, which modifies Annex XI of the legislative decree of 14 March 2003, n. 65. The new decree deals with the new procedures for notifying dangerous mixtures before placing them on the market. We also remind you that the annual fee of 50 euros must be paid each year despite the new PCN format.

EFSA: TITANIUM DIOXIDE E171 USED AS A FOOD ADDITIVE

EFSA has re-evaluated the use of titanium dioxide E171 as a food additive as recent studies have highlighted possible genotoxic effects. Titanium dioxide (E 171) contains a maximum of 50% nanoparticles to which consumers may be exposed.

In 2019, EFSA published a statement on the review of the risk of exposure to this food additive carried out by the French Agency for Food Safety, Environment and Health at Work (ANSES). In the statement, EFSA stressed that the ANSES opinion reiterated the uncertainties and gaps in the data already identified by EFSA without presenting findings that invalidated the Authority's previous conclusions on the safety of titanium dioxide. In the same year (2019) the Netherlands Authority for the Safety of Food and Consumer Products (NVWA) issued an opinion on the possible health effects of titanium dioxide as a food additive, highlighting the importance of to study the toxicological effects on the immune system as well as the potential effects of reproductive toxicity.

EUROPEAN COMMISSION: REACH AND CLP REVIEW

The European Commission has published two comprehensive Initial Impact Assessments (IIAs) on its strategic chemicals actions, paving the way for potentially significant changes to REACH and CLP, which industry must adapt to. The strategy, published last October, is committed to delivering more than 50 wide-ranging actions that are expected to be completed by 2024.

Regarding REACH, the Commission is evaluating the following measures:

- Review of registration requirements: will explore options, including more information on hazards of concern, documentation on safe use, registration of certain polymers and information on the environmental footprint;
- simplification of communication in supply chains;
- review of the provisions for dossier and substance evaluation;
- reform of the authorization process;
- reform the restriction process;
- review the provisions on application; is
- introduction of a mixture assessment factor (MAF).

The Commission will carry out a public consultation on options in the first quarter of 2022, with the intention of adopting new legislation in the fourth quarter of the same year.

The Commission will consider several options for a revision of CLP, including:

- introduction of new hazard classes (such as endocrine disturbances) and corresponding criteria;
- a new obligation to provide information on certain hazards on the label for products currently outside the scope of CLP;
- clarify the obligations to classify mixtures and some complex substances;
- introduce the possibility of making proposals and setting harmonized environmental and safety values for some substances;
- require importers and downstream users to provide information on substances classified for physical effects or health risks to poison centres and clarify the obligations for distributors to submit this information through an only representative or other means;
- the introduction of a mandate for the Commission to request the ECA to develop new harmonized classification and labeling dossiers;
- introduction of tailor-made labeling rules where there is not enough space on the packaging; is
- the launch of a prioritization mechanism for the harmonization of the classification of certain chemicals.

The Commission plans to launch a public consultation in the second quarter of this year, with adoption scheduled for the fourth quarter.

A reopening of the cosmetics regulation is also expected this year.

KKIDIK (TURKISH REACH): LATE PREREGISTRATION ACCEPTED BY TURKISH AUTHORITY ONLY EARLY 2021

ACT NOW IF YOU LOST THE LAST DEADLINE



In 2017, Turkey published and consolidated the text of the KKIDIK regulation regarding chemicals that can be placed on local national market. The scheme adopted follows the European REACH regulation in many prescriptions, so much so that it is often referred to as Turkey-REACH.

One of the significant differences is that there is only one registration deadline for all tonnage bands, set for 31/12/2023.

At this stage, the possibility is open to pre-register by 31/12/2020 but the Turkish government seems to accept late preregistration until 31.12.2023.

Moreover, in the last quarter of 2021 The MoEU will add a sub-tool into the KKS in order to generate Chemical Safety Report.

As for REACH EU, applicants must be Turkish legal entities. Non-Turkish companies that want to keep the market will have to appoint a local OR (only Representative). RNI srl can offer this service.

SEA UPDATES:

The SEA CLP like Regulation has been updated, adding 110 new substances to the Harmonized List of classification and labeling "and new hazard classifications. Furthermore, only polymers must be notified and not their ingredients.
