RESTRICTION TO INKS IN TATTOOS AND PERMANENT MAKEUP



Regulation (EU) 2020/2081 was published in the Official Journal of the European Union which made changes to Annex XVII of the REACH regulation concerning restrictions. Specifically, the restriction adopted takes into consideration the mixtures used for tattoos and permanent make-up that contain substances falling into the following hazard classes:

- carcinogenicity, mutagenicity, toxicity for reproduction of category 1A, 1B or 2;
- skin sensitization of category 1.1A or 1B;
- skin corrosion of category 1, 1A, 1B, 1C;
- skin irritation category 2;
- serious eye damage category 1;
- eye irritation category 2;
- and the substances listed in Annex II (list of prohibited substances) and Annex IV (list of dyes) of the Cosmetics Regulation (Regulation No. 1223/2009 and subsequent amendments).

The restriction came into force on January 4, 2021.

FRANCE: ANSES HAS PUBLISHED THE LIST OF PRIORITY CHEMICALS WITH ED FUNCTION



The Ministry of the Environment and the Ministry of Health have commissioned ANSES to develop two methodological tools to focus efforts on priority substances and carry out a rigorous assessment of their properties as potential endocrine disruptors. These two tools are:

- A list of substances considered to be of interest due to their potential endocrine action, associated with a prioritization strategy.
- A method of expertise to weigh the scientific evidence identifying a substance as an endocrine disruptor in order to classify it as "known", "suspected" or "suspected".

This initial list is based on India's DEDuCT database, supplemented by co-formulants and active substances covered by the Plant Protection Products Regulation (PPPR) or the Biocides Regulation (BPR). Some of them are already being investigated for their endocrine disrupting properties under the European regulatory framework.

Of the 906 substances present, ANSES was able to identify 16 priority substances.

BIOCIDAL PRODUCTS: THE APPROVAL OF TWO ACTIVE SUBSTANCES IS COMING



The Committee on Biocidal Products (BPC) will discuss two widely used active substances, quaternary ammonium compounds, at the BCP 41 meeting end of November 2021. The actives are DDAC and ADBAC. A favorable opinion was issued on them at the end of 2020, for the type of product PT3 and PT4. BPC 41 will discuss PT1 and PT2.

In fact, DDAC (Didecylidimethylammonium chloride) and ADBAC (Alkyl (C12-16) dimethylbenzyl ammonium chloride) are well known disinfectants and widely used by both professionals and the general public. They are quite effective against enveloped bacteria, yeasts and viruses, in both clean and dirty conditions. For these reasons, they can be used as a one-stop solution for cleaning and disinfection.

KKIDIK (TURKISH REACH): LATE PREREGISTRATION ACCEPTED BY TURKISH AUTHORITY ONLY EARLY 2021

ACT NOW IF YOU LOST THE LAST DEADLINE



In 2017, Turkey published and consolidated the text of the KKIDIK regulation regarding chemicals that can be placed on local national market. The scheme adopted follows the European REACH regulation in many prescriptions, so much so that it is often referred to as Turkey-REACH.

One of the significant differences is that there is only one registration deadline for all tonnage bands, set for 31/12/2023.

At this stage, the possibility is open to pre-register by 31/12/2020 but the Turkish government seems to accept late preregistration until 31.12.2023.

Moreover, in the last quarter of 2021 The MoEU will add a sub-tool into the KKS in order to generate Chemical Safety Report.

As for REACH EU, applicants must be Turkish legal entities. Non-Turkish companies that want to keep the market will have to appoint a local OR (only Representative). RNI srl can offer this service.

SEA UPDATES:

The SEA CLP like Regulation has been updated, adding 110 new substances to the Harmonized List of classification and labeling "and new hazard classifications. Furthermore, only polymers must be notified and not their ingredients.
