**NEW INDICATIONS ON HARMONIZED MARKING ON
SINGLE-USE PLASTIC PRODUCTS**



On February 1, 2021, Regulation (EU) 2019/1148, published in June 2019, relating to the placing on the market of explosives precursors, will come into force. This new regulation aims to prevent the illicit manufacture of explosives by limiting the access and use of precursors by private individuals, encouraging the reporting of suspicious transactions along the entire supply chain. The new rules will limit private access to restricted substances: for example, Sulfuric Acid cannot be sold to the public if present in a mixture at a concentration greater than 15% w / w.

Each Member State will have to establish a licensing system to regularize the purchase and possession of certain substances precursors of explosives by the citizen.

Furthermore, the rules will apply to both online and offline purchases.

RESTRICTION OF TDFA IN SPRAYS



The European Commission has adopted an amendment to Annex XVII of CLP which limits the use of TDFA in spray products. According to the regulation, the substance cannot be used in aerosol dispensers and

pump sprays, supplied to the public after January 2, 2021, in a concentration equal to or greater than two parts per billion by weight of mixtures containing organic solvents. In addition, products must be marked as "for professional use only" and "fatal if inhaled" (H330) with a Globally Harmonized System pictogram.

- 30.04.2021 GRANDFATHERING deadline
- 27.10.2021 DUIN deadline
- From 28.10.2021 start the PERIOD OF REGISTRATION:
 - 27.10.2023 Registration deadline with $t / a > 1000$
 - 27.10.2025 Registration deadline with t / a between 100-1000
 - 27.10.2027 Registration deadline with t / a between 1-10 and 10-100

GB BPR - ART.95 LIST, ACTIVE SUPPLIERS

To be included in the list of ACTIVE SUPPLIERS C

- Companies must provide useful information to HSE
- HSE will evaluate the dossier
- suppliers must be based in the UK within 24 months
- by 31.12.2022 there will be confirmation of inclusion in the supplier list

GB BPR - NOTIFICATION UNDER EVALUATION

- resubmission of the application to HSE by 31.03.2021 if UK is a Reference Member State
- resubmission of the application to HSE by 26.06.2021 if UK is a Concerned Member State

- companies must be based in the UK by 31.12.2021

FREE TRADE AGREEMENT SIGNED BETWEEN TURKEY AND UK



On 1 January 2021, the free trade agreement between Turkey and the United Kingdom came into force, which affects the automotive, steel, agricultural and manufacturing sectors.

The new agreement seems to replicate the trading terms of the previous pact, with duty-free trade for all non-agricultural products. It also contains a review clause within the next two years to consider further services, including digital ones, and more liberal trade and agriculture regulations.

**KKIDIK (TURKISH REACH): LATE PREREGISTRATION
ACCEPTED BY TURKISH AUTHORITY ONLY EARLY
2021**

ACT NOW IF YOU LOST THE LAST DEADLINE



In 2017, Turkey published and consolidated the text of the KKIDIK regulation regarding chemicals that can be placed on local national market. The scheme adopted follows the European REACH regulation in many prescriptions, so much so that it is often referred to as Turkey-REACH. One of the significant differences is that there is only one registration deadline for all tonnage bands, set for 31/12/2023.

At this stage, the possibility is open to pre-register by 31/12/2020 but the Turkish government decided to accept late preregistration after the deadline.

As for REACH EU, applicants must be Turkish legal entities. Non-Turkish companies that want to keep the market will have to appoint a local OR (only Representative). RNI srl can offer this service.

SEA UPDATES:

The SEA CLP like Regulation has been updated, adding 110 new substances to the Harmonized List of classification and labeling "and new hazard classifications. Furthermore, only polymers must be notified and not their ingredients.
