UK: OPEN CONSULTATIONS ON FUTURE REGULATION OF MEDICAL DEVICES IN UK OPEN



The Medicines and Healthcare Products Regulatory Agency (MHRA) invites the public to provide their views on possible changes to the regulatory framework for medical devices in the UK. The Regulation will enter into force on 1 July 2023 with adequate transitional provisions.

HSE: UPCOMING GB ACTIVE SUBSTANCE RENEWAL SUBMISSION DEADLINES



Under the GB Biocides Regulation (GB BPR), active substance approvals will expire unless a renewal application is submitted at least 550 days prior to the expiration date.

The following active substances or product-type combinations have the following expiry dates:

If a renewal application is not submitted for the above active substance/product type combinations under GB BPR, the approvals will expire. This means the active substances can no longer be used in biocidal products of the relevant product types in Great Britain.

SINGAPORE: FOOD (AMENDMENT) REGULATIONS 2021

The Food (Amendment) Regulations 2021 will come into operation on 1 October 2021. This set of amendments make changes to the Food Regulations, mainly to allow the use of new food additives and ingredients, extend the use of existing food additives, revise the maximum limits for heavy metals in food to be in line with international standards, as well as to ensure coherence in legislation. With effect from 1 October 2021, all traders may make use of the new provisions for food additives and ingredients, subject to the conditions laid out in the Food Regulations. Traders are also reminded to ensure that your food products available for call on or effort 1 October 2021 (Canadara)

your food products available for sale on or after 1 October 2021 comply with the requirements. SFA (Singapore Food Agency) will facilitate traders to comply with these requirements.

KKIDIK (TURKISH REACH): LATE PREREGISTRATION ACCEPTED BY **TURKISH AUTORITHY ONLY EARLY 2021**

ACT NOW IF YOU LOST THE LAST DEADLINE



In 2017, Turkey published and consolidated the text of the KKIDIK regulation regarding chemicals that can be placed on local national market. The scheme adopted follows the European REACH regulation in many prescriptions, so much so that it is often referred to as Turkey-REACH.

One of the significant differences is that there is only one registration deadline for all tonnage bands, set for 31/12/2023.

At this stage, the possibility is open to pre-register by 31/12/2020 but the Turkish government seems to accept late preregistration until 31.12.2023.

Moreover, in the last guarter of 2021 The MoEU will add a sub-tool into the KKS in order to generate Chemical Safety Report.

As for REACH EU, applicants must be Turkish legal entities. Non-Turkish companies that want to keep the market will have to appoint a local OR (only Representative). RNI srl can offer this service.

SEA UPDATES:

The SEA CLP like Regulation has been updated, adding 110 new substances to the Harmonized List of classification and labeling "and new hazard classifications. Furthermore, only polymers must be notified and not their ingredients.
