NEW AMENDMENT OF CLP ANNEX VIII



The second amendment to Annex VIII to CLP was published in the Official Journal on 13 November 2020 and entered into force on 14 November 2020.

An updated guidance on the harmonizated information to be submitted with the new NCP notifications is currently under preparation.

The main changes are reletato to how reporting on the composition of mixtures of UVCB, such as fuels and petroleum products, as well as some construction products which can be highly variable or sometimes unknown.

The main updates on the PCN dossier concern:

- 1. Standard formula: ECHA has prepared a dataset in collaboration with CEMBUREAU
- 2. Group of interchangeable components (ICG) in Mixtures in Mixtures (MiM)
- Update of the EuPCS list: new categories are added for Medical Devices, divided categories for E-liquids and the new category for pyrotechnic products
- 4. New justifications when pH is not available: justification is mandatory (BR621)
- 5. New reasons for the update: delection or correction of the trade name, expansion of the market area

SUBMISSION SCIP NOTIFICATIONS




The purpose of the SCIP is to reduce the amount of hazardous substances in products and materials, including the recycled ones. From 28 October 2020 it is possible to make SCIP notifications, which from 5 January 2021 will be mandatory for the entire supply chain except for retailers.

It is very important to check whether SVHC substances with concentrations higher than 0.1% are present in the article. In addition, it is necessary to provide sufficient information to ensure the safe use of the item, considering all stages of the life cycle as well as improper use, recycling and disposal.

For completely identical articles that is articles with the same function or use, same physical form or same chemical composition, it is possible to make a "grouping" notification covering all identical articles. Almost identical items, on the other hand, are items that have the same function or use, contain the same Candidate List Substance, the material with which they are made is the same as well as the instructions for safe use. These items can be notified in a single application as long as the identical items are correctly identified. For more information press the bottom below

NEW ZELAND AND BRAZIL CLOSE TO GHS V.7



On November 5th, 2020, New Zealand's Environmental Protection Authority (EPA) announced that the government has approved the application of the GHS Rev.7 classification system for hazardous substances. The new system will be adopted on 30th April 2021 and will replace the current HSNO classification system. A transitional period of 4 year will be provided for the chemicals approved before the new regime came into effect.

The Brazilian Association for Technical Standardization (ABNT) proposed a revision to the national technical standard on chemical labelling and hazard communications to fit the requirements of GHS R.7. This new proposal should replace the current four-volume standard with a new one which has 17 annnexes. Up to two-year transition period will be gioven for enterprises to adapt to the new standard. The public consultation ended on November 19th.

KKIDIK (TURKISH REACH): PREREGISTRATION DEADLINE SET ON 31/12/2020.



In 2017, Turkey published and consolidated the text of the KKIDIK regulation regarding chemicals that can be placed on local national market. The scheme adopted follows the European REACH regulation in many prescriptions, so much so that it is often referred to as Turkey-REACH.

One of the significant differences is that there is only one registration deadline for all tonnage bands, set for 31/12/2023.

At this stage, the possibility is open to pre-register by 31/12/2020.

As for REACH EU, applicants must be Turkish legal entities. Non-Turkish companies that want to keep the market will have to appoint a local OR (only Representative). RNI srl can offer this service.
