## NEW OECD TEST GUIDELINE ON SKIN SENSITIZATION



A new skin sensitization guideline helps to reduce animal testing for chemicals by combining different data sources to improve skin sensitization test results using alternative testing methods. The guideline is the first to include IT forecasting advice with tools such as QSAR Toolbox, a software developed jointly by ECHA and OECD.

The guideline was developed in a joint effort between the OECD, the EU Joint Research Center, national governments and ECHA.

## COLOMBIA: NEW GHS



The Colombian Ministry of Labor defines new actions for employers to apply the Globally Harmonized System (GHS) of classification and labeling of chemicals in the workplace. The new Resolution No. 0773 of 2021 aims to guarantee the protection and health of workers, facilities and the environment against the use of potentially dangerous chemicals and defines the responsibility of companies.

Among other novelties:

- Employers must ensure the classification of chemicals through the UN GHS
- Establishment of information consultation portals
- Clarification of the conditions for the labeling of dangerous products, mixtures or alloys.
- Establish a transition regime of 24 months for diluted chemicals and substances and 36 months for mixtures.

**EUROPEAN COMMISSION: RAC AND SEAC'S OPINIONS**

The Risk Assessment Committee (RAC) adopted its opinion in support of Germany's proposal to limit PFHxA, its salts and related substances. A consultation of the Committee for Socio-Economic Analysis (SEAC) on the same group of chemicals will start in early July.

Persistent and volatile PFHxAs contribute to increasing environmental pollution and human exposure. RAC believes that the proposed restriction could be effective in reducing PFHxA emissions and related risks. SEAC approved its draft opinion on the costs and benefits of the proposal for society and was able to reach a conclusion on the restriction of these substances in certain uses.

In addition, among the various consultations in June, the RAC adopted an important opinion on the scientific assessment of occupational exposure limits (OELs) for asbestos, as well as opinions on nine proposals for harmonized classification and labeling (CLH). The Committee also continued discussions at the request of the Executive Director of ECHA on the environmental properties of lead.

## KKIDIK (TURKISH REACH): LATE PREREGISTRATION ACCEPTED BY TURKISH AUTHORITY ONLY EARLY 2021

**ACT NOW IF YOU LOST THE LAST DEADLINE**



In 2017, Turkey published and consolidated the text of the KKIDIK regulation regarding chemicals that can be placed on local national market. The scheme adopted follows the European REACH regulation in many prescriptions, so much so that it is often referred to as Turkey-REACH.

One of the significant differences is that there is only one registration deadline for all tonnage bands, set for 31/12/2023.

**At this stage, the possibility is open to pre-register by 31/12/2020 but the Turkish government seems to accept late preregistration until 31.12.2023.**

Moreover, in the last quarter of 2021 The MoEU will add a sub-tool into the KKS in order to generate Chemical Safety Report.

As for REACH EU, applicants must be Turkish legal entities. Non-Turkish companies that want to keep the market will have to appoint a local OR (only Representative). RNI srl can offer this service.

### SEA UPDATES:

The SEA CLP like Regulation has been updated, adding 110 new substances to the Harmonized List of classification and labeling "and new hazard classifications. Furthermore, only polymers must be notified and not their ingredients.
