NEW REACH DOSSIER UPDATE DEADLINES BECAME MANDATORY



The European Commission is set to adopt new EU-wide deadlines on updates to REACH registrations in the autumn, which will begin to apply two months later by the end of 2020. All Member States unanimously approved the draft document.

It will mean that, for the first time, industry is legally obligated to add any new relevant information to their dossiers within a set time period.

The measure comes after persistent issues with dossier non compliance.

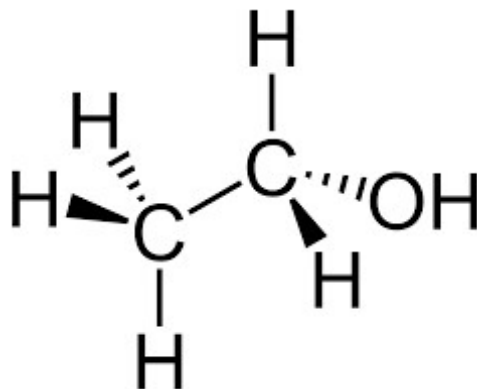
It fortifies legal provisions under REACH Article 22 which, until now, has required registrants to update *"without undue delay"*. This has resulted in companies interpreting the rules differently and, in some cases, failing to execute updates unless requested directly by ECHA.

The official document will be published by the Autumn 2020.

GREECE PROPOSES A NEW CLASSIFICATION FOR ETHANOL



On 27 July 2020, the proposed new harmonized classification for ethanol (CAS: 64-17-5) supported by Greece was included in the register of intentions (RoI):

Flam. Liq. 2, H225
Eye Irrit. 2, H319
Repr. 2, H361d
Lact. H362
STOT SE 3, H336
STOT RE 2 *, H373 **

which would replace the previous one:

Flam. Liq. 2, H225

The approval process is very long. This is only a preliminary stage. The official submission of the application by Greece is expected by the end of the year, which will subsequently be evaluated by the technical committees. Only after the RAC opinion has been issued can the final classification be adopted.

KKIDIK (TURKISH REACH): PREREGISTRATION DEADLINE SET ON 31/12/2020.



In 2017, Turkey published and consolidated the text of the KKIDIK regulation regarding chemicals that can be placed on local national market. The scheme adopted follows the European REACH regulation in many prescriptions, so much so that it is often referred to as Turkey-REACH. One of the significant differences is that there is only one registration deadline for all tonnage bands, set for 31/12/2023.

At this stage, the possibility is open to pre-register by 31/12/2020.

CONSULTATIONS OPENED FOR NEW HARMONIZED CLASSIFICATIONS



The ECHA is looking for comments on the harmonised classification and labelling proposals for:

- clothianidin (ISO); (E)-1-(2-chloro-1,3-thiazol-5-ylmethyl)-3-methyl-2-nitroguanidine (EC 433-460-1, CAS 210880-92-5);
- 1-phenylethan-1-one (1-phenylethylidene)hydrazone (EC 211-979-0, CAS 729-43-1);
- diphenyl(2,4,6-trimethylbenzoyl)phosphine oxide (EC 278-355-8, CAS 75980-60-8);
- dimethyl propylphosphonate (EC 242-555-3, CAS 18755-43-6);
- cymoxanil (ISO); 2-cyano-N-[(ethylamino)carbonyl]-2-(methoxyimino)acetamide (EC 261-043-0, CAS 57966-95-7). For this substance, the combined format including the draft renewal assessment report and the proposal for harmonised classification and labelling has been used. The Commission's Guidelines on active substances and plant protection products, and EFSA's assessment report give additional information.

The deadline for comments is **23 October 2020**.
