CLP AMENDMENTS

The amendments of Regulation 1272/2008 and Annex VIII have been published in the Official Journal of the European Union. The amendments of the Annex VIII concerns, in particular, the postponement of the first date of compliance for notification of mixtures intended for consumer uses, from the 1st January 2020 to the 1st January 2021. Moreover, new details concerning the UFI are given.

BPA RESTRICTION



It has entered in force the restriction of BPA in the thermal paper on the 2nd of January of this year. BPA contained in thermal paper in concentrations equal to or above 0.2 % by weight cannot be placed on the market.

SVHC NEW SUBSTANCES

The number of chemicals present in the candidate list of substances of very high concern has increased to 205 from the last update. Four new substances have been included in the SVHC list by ECHA. Three of them due to reproduction toxicity properties and a 4th due to an association of different properties of concern.

UPDATE OF SIN LIST

The Substitute It Now List, known also as the SIN list, has been updated with new chemicals entries in November 2019. The NGO ChemSec's list has the aim to gather hazardous substances, which are used in articles, products and manufacturing processes, that should be removed since they are dangerous to human health and the environment. 60 new chemicals have been included to the list: 29 persistent, mobile and toxic compounds (PMT); 16 persistent, bioaccumulative and toxic (PBT); 14 carcinogenic, mutagenic or reprotoxic (CMR) substances; and the first nanomaterial on the list – carbon nanotubes. The list counts 991 compounds until now.

UNI RSDS REFERENCE PRACTICE

From 10 June 2019 the UNI / PdR 60: 2019 Reference Practices is available on the UNI (Italian Standardization Body) website. The latest concerns the Expert on the Life Cycle of Substances - Activities and requirements of the professional profiles as Safety Data Sheet Manager (RSDS) and Waste System Expert (ESR). The practice defines the professional profile of the RSDS, which achieves a key role in ensuring the compliance, consistency, correctness of the SDS, the exposure scenarios and the hazardous labels.

The European agency will begin to elaborate a positive list of substances that can be safely utilized in materials that come into contact with drinking water. 1500 chemicals are predicted to be present in the initial EU positive list and it will be adopted by the EU commission by 4 years.

GHS IS ADOPTED BY AUSTRALIAN GORNMENT

The Australian Government Safe Work Australia (SWA), on the 10th of January 2020, has agreed to endorse the Globally Harmonized System of Classification and Labelling of Chemicals (GHS). The SWA will adopt GHS starting from 1 July 2020, with a transitional period that will last 2 years.
